Legally Responsible Adults: Online Submission Portal Frequently Asked Questions

ARIS Solutions has introduced an online submission platform for Children's Personal Care Legally Responsible Adult invoices.

Please use this Frequently Asked Questions sheet for instructions.

What is the web address to access the new online submission portal? https://arissolutions.org/fms-payment-submission/

Am I required to submit through the online submission portal?

No, forms can be submitted by mail.

Can I submit an employee's timesheet through the online submission portal?

No. Employee timesheets are not currently accepted through the online submission portal. If a timesheet is submitted, it will remain unpaid, and returned to you, the employer.

Who can submit the LRA form?

The LRA form can be submitted by the individual authorized to receive the Legally Responsible Adult payment.

What is the password to access the online submission portal?

Password: ENTER

The password is: ArisSubmission%4409

What name do I enter in the "name" fields during my submission?

Name (Required)

The name on the submission must be for the individual receiving the payment.

How many Legally Responsible Adult Payment Forms can be attached in one submission?

One. If you have multiple forms, attach one form to each submission.

Is there an email confirmation?

No. A unique confirmation code will appear on your screen once an LRA form has been successfully submitted.

Do I need to keep the unique confirmation code provided?

Yes, write the unique code on the original document. If you have questions about your submission, ARIS staff will ask for this code.

Do I need an account to access the new online portal?

No! The online submission portal does not require an account to access. If you have been asked for log-in information, then you have likely arrived at our electronic timesheet option. If you are interested in enrolling in e-timesheets, please reach out to our Customer Service team for assistance.

What is the deadline for my online portal submission?

The deadline for a submission through the online portal is 12pm the Monday before the pay date.

What happens if the LRA is sent after the deadline?

If the LRA form is received late, ARIS will process the submission on the next regularly scheduled CPCS pay date.
